    - a) Three similar completed works costing not less than the amount equal to 40 % of the estimated amount.

b) Two similar completed work costing not less than the amount equal to 50 % of the estimated cost.

or

c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
